WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of **Covered Court** located at **Ayala Alabang Village, Barangay Ayala-Alabang, Muntinlupa City** is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **February 6, 2010**, the City Government of Muntinlupa entered into Construction Agreement with **PDJ Integrated Construction** for the construction of the project **Covered Court** amounting to Seven Million Nine Hundred Twenty Five Thousand Fourteen Pesos And 08/100 (Php7,925,014.08) as a result of a public bidding held on **January 28, 2010**;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to **PDJ Integrated Construction** as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;
