A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CLTY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF COVERED COURT LOCATED AT AYALA ALABANG VILLAGE, BARANGAY AYALA-ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN MILLION NINE HUNDRED TWENTY FIVE THOUSAND FOURTEEN PESOS AND 08/100 (PHP7,925,014.08) WHICH AMOUNT SHALL BE TAKEN FROM THE EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECT.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of Covered Court located at Ayala Alabang Village, Barangay Avala-Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on February 6, 2010, the City Government of Muntinlupal entered into Construction Agreement with PDJ Integrated Construction for the construction of the project Covered Court amounting to Seven Million Nine Hundred Twenty Five Thousand Fourteen Pesos And 08/100 (Php7,925,014.08) as a result of a public bidding held on January 28, 2010;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to PDJ Integrated Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on February 1, 2010, the Bids and Awards Committee (BAC) approved Resolution No. 1-1-10-001, "declaring the PDJ Integrated Construction as the bidder with the Lowest Calculated Responsive Bid for the construction of Covered Court located at Ayala Alabang Village, Barangay Ayala-Alabang, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the *Supreme Court* (SC) decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

San Pedro, in behalf of the City Government of Muntinlupa with PDJ Integrated Construction for the project covered court located at Ayala Alabang Village, Barangay Ayala-Alabang, Muntinlupa City in the amount of Seven Million Nine Hundred Twenty Five Thousand Fourteen Pesos And 08/100 (Php7,925,014.08).
