WHEREAS, the City Government of Muntinlupa owns a one (1) hectare property located at Susana Heights Corner National Road, Tunasan, Muntinlupa City which is allocated/intended to be the site of all National Government Offices stationed in the City;

WHEREAS, aside from the offices under the Department of Justice (DOJ), the Land Registration Authority (LRA) has also signified its intention to transfer the **Register of Deeds for Muntinlupa City** to the aforesaid government center in the soonest time possible;

WHEREAS, the Land Transportation Office Muntinlupa Satellite Office is presently located at National Road, Tunasan, Muntinlupa City near SM Hypermart;

WHEREAS, the said location present a multifarious disadvantages to the agency it being a subject of several complaints not only from its clients but also to the riding public;

WHEREAS, some of the complaints lodged at the Office of the Mayor were the frequent flooding in the area; rampant activities of illegal fixers and occurrence of crimes; proneness to traffic congestion due to its proximity to a shopping mall and the inconvenience to its clientele posed by its location:

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, requesting the Land Transportation Office (LTO) to transfer the LTO-Muntinlupa Satellite Office from its present location (National Road, Tunasan, Muntinlupa City Near SM Hypermart) to the City's Government Center, a one (1) hectare property of the City allocated to all National Government Offices stationed in Muntinlupa City.
