WHEREAS, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations". The Sangguniang Panlungsod shall act on the RE-APPOINTMENT within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, DR. RAQUEL P. TOLENTINO, was born in Manila, graduated her Primary and Secondary School at the Immaculate Heart of Mary in Quezon City, and in 1994 she graduated Doctor of Dental Medicine at the University of the East College of Dentistry and took her Master in Business Administration at the Pamantasan ng Lungsod ng Muntinlupa (PLMun);

WHEREAS, in February 1995, DR. RAQUEL P. TOLENTINO passed the Board of Dentistry Examination given by the Professional Regulation Commission (PRC);

WHEREAS, from July 02, 2001 to February 28, 2003, DR. RAQUEL P. TOLENTINO started working as clerk III at the Vice Mayor's Office with a casual status; by April 2005 to June 2007, Dr. Raquel P. Tolentino was elevated to Community Affairs Officer I at the Drug Abuse Prevention and Control Office;

WHEREAS, from July 01, 2007 to September 13, 2009, Dr. Raquel P. Tolentino was appointed as the Officer-In-Charge of the Drug Abuse Prevention and Control Office;
