A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH KCD BUILDERS FOR THE PROJECT PROPOSED LAND DEVELOPMENT (EARTHWORKS) LOCATED AT HALL OF JUSTICE SITE, TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION EIGHT HUNDRED TWO THOUSAND SIX HUNDRED THIRTY PESOS AND 10/100 (PHP5,802,630.10) WHICH AMOUNT SHALL BE TAKEN FROM THE 2011 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECT.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances":

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS. the construction of Proposed Land (Earthworks) located at Hall Of Justice Site, Tunasan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on May 5, 2011, the City Government of Muntinlupa entered into Construction Agreement with KCD Builders for the construction of the project amounting to Five Million Eight Hundred Two Thousand Six Hundred Thirty Pesos and 10/100 (PHP5,802,630.10) as a result of a public bidding held on April 4, 2011;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to KCD Builders as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on *April 28, 2011*, the Bids and Awards Committee (BAC) approved *Resolution No. 1-04-002-11*, "declaring the *AM-FM Builders* as the bidder with the Lowest Calculated Responsive Bid for the construction of Proposed Land Development (Earthworks) at Hall of Justice Site, Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with KCD Builders for the project proposed land development (Earthworks) located at Hall of Justice Site, Tunasan, Muntinlupa City in the amount of Five Million Eight Hundred Two Thousand Six Hundred Thirty Pesos And 10/100 (Php5,802,630.10) which amount shall be taken from the 2011 Executive Budget under Infrastructure Project.
