WHEREAS, the construction of **CONSTRUCTION OF POLICE AND FIRE STATION (PHASE IV)** located at Barangay Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **April 28, 2011**, the City Government of Muntinlupa entered into **Construction Agreement** with **KCD Builders** for the construction of the project amounting to **SIXTEEN MILLION TWO HUNDRED NINETY THOUSAND FIVE HUNDRED EIGHTEEN PESOS (PHP16,290,518.00)** as a result of a public bidding held on **March 15, 2011**;

San Pedro, in behalf of the City Government of Muntinlupa with **KCD Builders** for the project construction of **Police and Fire Station (Phase IV)** located at **Barangay Alabang, Muntinlupa City** in the amount of **Sixteen Million Two Hundred Ninety Thousand Five Hundred Eighteen Pesos (Php16,290,518.00)** which amount shall be taken from the **2008 Supplemental Budget No. 1 - Infrastructure Project**.
