A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR THE PROJECT INSTALLATION OF STREETLIGHTS LOCATED AT ALABANG TO SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF FIFTEEN MILLION THIRTY FOUR THOUSAND TWO HUNDRED SIX PESOS (PHP15,034,206.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 SUPPLEMENTAL BUDGET NO. 1 - INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the *Installation Of Streetlights* located at *Barangay Alabang to Barangay Sucat, Muntinlupa City* is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on *April 28, 2011*, the City Government of Muntinlupa entered into Construction Agreement with **AM-FM Builders** for the construction of the project amounting to **Fifteen Million Thirty Four Thousand Two Hundred Six Pesos (PHP15,034,206.00)** as a result of a public bidding held on **March 15, 2011**;

**WHEREAS**, on **April 18, 2011**, the Bids and Awards Committee (BAC) approved **Resolution No. I-03-001-11**, "declaring the **AM-FM Builders** as the bidder with the Lowest Calculated Responsive Bid for the construction of installation of streetlights at Barangay Alabang to Barangay Sucat, Muntinlupa City and recommend the approval by the City Mayor;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod**, to ratify the **Construction Agreement** entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **AM-FM Builders** for the project Installation of Streetlights located at Barangay Alabang to Barangay Sucat, Muntinlupa City in the amount of **Fifteen Million Thirty Four Thousand Two Hundred Six Pesos (Php15,034,206.00)** which amount shall be taken from the **2008 Supplemental Budget No. 1 - Infrastructure Project under the Executive Budget**.


