Aldrin L. san Pedro** to enter into a **Loan Agreement** for the upgrading of the computer network system currently utilized by revenue-generating departments of the city government in order to optimize collection efficiency and to provide the most convenient services for taxpayers, which shall be taken from the pre-approved loan given by the **Development Bank of the Philippines (DBP)**.
