A RESOLUTION CLARIFYING THE AMOUNT OF RISK REDUCTION FEE BEING IMPOSED UNDER CITY ORDINANCE NO. 10-019 FOR PURPOSES OF AVOIDING CONFUSION ON THE PART OF BOTH THE TAX COLLECTORS AND THE TAXPAYERS.

**WHEREAS**, the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa has enacted Ordinance No. 10-019 for the purpose of providing funds for the City's risk reduction and disaster mitigation initiatives, disaster management plans and programs, and facilities, connected therewith, a payment of risk reduction fee is required of all business establishments;

**WHEREAS**, Section 4 of the aforesaid ordinance provides that the amount of Risk Reduction Fee (RRDM) to be imposed on every business establishment shall be **ten percent (10%) of the one percent (1%) of the business tax due**, on the other hand, the Minutes during the session on the said ordinance particularly in **Lines 38 to 44** thereof, appears that the **Risk Reduction Fee (RRDM) shall be 10% of 1% of the said annual gross sales/receipts** (referring to the annual gross sales or receipts of a business establishment);

**WHEREAS**, the latter phrase were moved for incorporation in the Ordinance by *Hon. Coun. Atty. Raul R. Corro*, duly seconded by Hon. Coun. Robert P. Baes, both Members of the Sangguniang Panlungsod, and since no one has objected thereto, the motion was duly approved by the Sanggunian. Hence, it was duly approved by the Sanggunian the phrase, "**the Risk Reduction Fee (RRDM) shall be 10% of 1% of the said annual gross sales/receipts**" should appear in the letter of Ordinance No. 10-019, however, the same cannot be read in the said ordinance;

**WHEREAS**, the foregoing conflicting and/or inconsistent provisions between the letter of Ordinance No. 10-019 and its Minutes must be clarified in the soonest times possible for purposes of avoiding confusion on the part of both tax collectors and the taxpayers;

**WHEREAS**, the letters of Ordinance No. 10-019 suffer from an error due to inadvertent omission of the very relevant phrase, as recorded in the Minutes, in the body of the Ordinance. The aforesaid defect can be cured by passing a resolution in a session duly called for the purpose;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, Metro Manila**, by virtue of the powers vested in it by Law, in Session assembled, to clarify that the amount of Risk Reduction Fee being imposed under City Ordinance No. 10-019 shall be **10% of 1% of the annual gross sales/receipts** of every business establishment for purposes of avoiding confusion on the part of both the tax collectors and the taxpayers.

**ADOPTED**, by the **6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** on its 4<sup>th</sup> day of ~~January~~ **2012**, on its 12<sup>th</sup> Special Session.
