**WHEREAS**, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations"*. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

**WHEREAS, ATTY. BYRON GABBUAT SAN PEDRO** graduated Bachelor of Science in Business Major in Management at the University of the East in 1991 and finished his Law studies in 1998 at the Arellano Law Foundation;

**WHEREAS, ATTY. BYRON GABBUAT SAN PEDRO** took Masteral Degree on Law at the University of Sto. Tomas from 2004 up to present;

**WHEREAS, ATTY. BYRON GABBUAT SAN PEDRO** passed the BAR Examination and thus became a Lawyer on May 06, 1999;

**WHEREAS**, before **ATTY. BYRON GABBUAT SAN PEDRO** became a lawyer, he first worked as Marketing/Personnel Manager at Asia King Inc., from 1998 to 1998 and Managing Partner of Mabuhay Ka Pinoy Realty from 1991 to present;


