WHEREAS, the Sangguniang Panlungsod of Muntinlupa adopt Ordinance No. 02-039, **"requiring all private and government originators operating and doing business or services within the City of Muntinlupa to secure accreditation from the Sangguniang Panlungsod and register with the Business Permit and Licensing Office (BPLO) and providing penalties for violation thereof"**;

WHEREAS, Section 3 of Ordinance No. 02-039, states that, **"the Urban Poor Affairs Office (UPAO)** through the Socialized Housing Program Committee (SHPCOM) shall evaluate and screen the application for accreditation of any private Mobilizer;

WHEREAS, a **Mobilizer** is an organization or a non-governmental organization who is supposed to help the community Association (CA) to get organized and registered with the appropriate government agency, document the loan and mortgage, assist the Community Association (CA) in the negotiations with the landowner for the purchase of the property and act as the creditor-mortgagee, then assign the rights to the loan and mortgage to the National Home Mortgage Finance Corporation (NHMFC), yet these functions have been abused by some Mobilizers, to the detriment of the poor community association's welfare;


