FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION FOR THE IMPLEMENTATION OF THE PHILHEALTH PARTIAL SUBSIDY SCHEME SPONSORED PROGRAM FROM SEPTEMBER 1, 2013 TO DECEMBER 31, 2013.

**WHEREAS**, the special provisions of the General Appropriations Act for Fiscal Year 2011 and 2012 only provided the National Government subsidy for health insurance premiums of indigents under the National Household Targeting System of Poverty Reduction (NHTS-PR) of the Department of Social Welfare and Development (DSWD), thereby not subsidizing all other constituents of the LGU not included in the NHTS-PR list;

**WHEREAS**, recognizing the need to provide basic package of personal health services to identified indigents not included in the National Household Targeting System for Poverty Reduction (NHTS-PR) list, to have health insurance coverage, the Corporation has approved, through Philhealth Board Resolution No. 1479, series of 2011, the implementation of the Partial Subsidy Scheme;

**WHEREAS**, the LGU has signified its intention and commits to enroll its identified beneficiaries under the Partial Subsidy Scheme from September 1, 2013 to December 31, 2013;

**WHEREAS**, for this purpose the Philippine Health Insurance Corporation submitted a Memorandum of Agreement (MOA) to the City government of Muntinlupa;

**WHEREAS**, in the draft Memorandum of Agreement (MOA) every member to be enrolled or to become a member under the Sponsored Program of the City Government, the latter has to pay a premium rate of One Thousand Two Hundred Pesos (Php1,200.00) effective on July 01, 2013 until December 31, 2013;

**WHEREAS**, there is Ten Million Pesos (Php10,000,000.00) allocated for the payment of the premiums of Eight Hundred Pesos (Php800.00) for every member and more than eight thousand (8,000) beneficiaries who can be enrolled or become members of the Philhealth Partial Subsidy Scheme Sponsored Program of the City Government for four (4) months period from September 1, 2013 to December 31, 2013, which amount shall be taken from the Philhealth Care Program of the 2013 Executive Budget;

**WHEREAS**, the enrollment/listing of members/beneficiaries shall be undertaken by the City Government thru the Social Services Department (SSD) and the Ospital ng Muntinlupa;

**WHEREAS**, if still necessary the members/beneficiaries to be enrolled shall be issued with Philhealth Identification Cards;

**WHEREAS**, the draft Memorandum of Agreement (MOA) submitted by the Philhealth shall be revised/finalized in accordance with this Resolution;

**RESOLVE**, therefore as it is hereby **RESOLVED** authorizing Hon. City Mayor Atty. Jaime R. Fresnedi to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum of Agreement (MOA) with the Philippine Health Insurance Corporation for the implementation of the Philhealth Partial Subsidy Scheme Sponsored Program effective September 01, 2013 to December 31, 2013.


