WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Mrs. Lualhati S. Morales as City Department Head II of Muntinlupa and has submitted the same for the confirmation by the City Council on August 22, 2013.


