WHEREAS, pursuant to Section 455(b), sub-paragraph (1) of the Local Government of 1991, the City Mayor, as Chief Executive of the City Government shall exercise general supervision and control over all programs, projects, services and activities of the City Government, xxx shall:

"(iv) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance xxx".

WHEREAS, the Bottom-Up Budgeting (BUB) and planning aims to make the planning and budgeting processes of both local and national government more participatory, by involving grassroots communities in the delivery of national service to poor communities as part of the poverty reduction effort of National Government Agencies and Local Government Units (LGUs);

WHEREAS, the City Government has been chosen as one of the beneficiaries of the program and as such it will be entering into a Memorandum of Agreement (MOA) with DOLE-NCR;

WHEREAS, the City Government of Muntinlupa through the Public Employment Service Office (PESO) will implement the BUB Project through Jobs Fair and SRS activities;

WHEREAS, the PESO needs to upgrade its capability by way of purchasing computers and office equipment through BUB Project;

WHEREAS, the releases of the foregoing amount shall be in accordance

with Section 4.3 of COA Circular 94-013 as follows:

> First Release - due on October 25, 2013 amounting to One Hundred Fifty Thousand Pesos (150,000.00) or an amount sufficient for three (3) months operations, subject to replenishment upon submission of reports of disbursement and accomplishment by the City Government of Muntinlupa.

> Second Release - due on November 8, 2013 amounting to Seventy Five Thousand Pesos (Php75,000.00) subject to replenishment upon submission of reports of disbursement and accomplishment by the City Government of Muntinlupa.

> Third Release - due on December 6, 2013 Seventy Five Thousand Pesos (Php75,000.00) subject to replenishment upon submission of reports of disbursement and accomplishment by the City Government of Muntinlupa.

NOW. THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi to enter into and sign a Memorandum of Agreement (MOA) with Department of Labor and Employment-NCR for the implementation of the Bottom-Up Budgeting (BUB) and planning.
