RESOLUTION

APPROVING THE PROJECT LISTING EMBODIED IN MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION ADOPTED ON MAY 7, 1990

WHEREAS, the Sangguniang Bayan acknowledges the receipt of Municipal Development Council Resolution No. 3, series of 1990, which embodies a list of project which shall be jointly funded from two visible sources namely: the Budgetary Aid to Local Government Units (BALGU) to finance the construction of the first phase of a Multi-Purpose Sports Center pursuant to DLG-DBM-DOF Joint Circular No. 1 of April, 1990, and the 20% Internal Revenue Allocation, to underwrite the costs of constructing the Second Phase of the Project and the concomitant administrative expenses for both phases;

WHEREAS, the in-depth and comprehensive study made by this local legislative body of the project showed the absolute necessity and desirability of the implementation of this project which seeks to put the utilization and enjoyment of sports, recreational, and reading facilities within the reach and at the disposal of the bottom 30% of the poor and underprivileged inhabitants of the municipality at a very appropriate, strategic, viable, and duly reserved costs free government lot situated at the Liwasan ng mga Bayani in Barangay Alabang, Muntinlupa, Metro Manila;

WHEREAS, by way of iteration parapharasing the second preambular provision of the subject Municipal Development Council Resolution, the project when realized will help bring about the maintenance of peace and order in our municipality, promote the administrative and technical capabilities of both barangays and municipal officials, foster and enhance practical and quality sportsmanship amongst the populace, and help alleviate the social and economic conditions of the people in the municipality, especially the preponderant 30% low income group, who can readily avail of the sports, recreational, and reading facilities of a typical Multi-Purpose Sports Center;

NOW, THEREFORE, on motion of Councilor Carlo G. Tensuan, duly seconded by Councilor Roman E. Niefes; and unanimously approved by all the Sangguniang Bayan Members present, there having been a quorum, the approval of the project listing embodied in Municipal Development Council Resolution No. 3, series of 1990, is hereby approved and adopted conformably to the pertinent provisions of DLG-DBM-DOF Joint Circular No. 1 of April, 1990 and DLG Unnumbered Memorandum Circular promulgated on April 15, 1990;
