RESOLUTION NO. 92-04

RESOLUTION EXPRESSING THE NOBLE INTENTION OF THE MUNICIPAL COUNCIL OF MUNTINLUPA, PHILIPPINES FOR THE MUNICIPALITY OF GUNMA, JAPAN TO BECOME ITS SISTER MUNICIPALITY.

WHEREAS, to promote cooperation, understanding and friendships between two neighboring countries, inter-governmental relationship must be established;

WHEREAS, in setting this goal, the end result will bring not only mutual understanding between the people of the two municipalities but will contribute to lasting peace and prosperity through the interaction of ideas, economic and technical know-how, cultural and educational awareness and other possible fields;

WHEREAS, these objectives are attainable and practicable by creating a bond between the municipalities of Muntinlupa and Gunma;

WHEREAS, as sister-municipality the ties between these two towns will be strengthened and the spirit of camaraderie shall prevail;

WHEREAS, the Municipality of Muntinlupa through its Council, does recognize and endorse this Resolution for this noble intention with the hope that the foregoing objectives would materialize.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF MUNTINLUPA, AS FOLLOWS :

Section I. That this Municipal Council on behalf of the people of the Municipality of Muntinlupa does hereby express the noble intention and extending with warm hands and its sincerest desire for Gunma to be a sister-municipality for the purpose of creating greater mutual understanding between the peoples of our two great municipalities and nations.

Section II. That copies of this Resolution are to be sent to the Mayor and Council of the Municipality of Gunma, Japan and the embassy of Japan.
