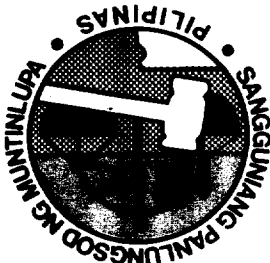

RESOLUTION NO. 232-95

RESOLUTION APPEALING TO THE FRENCH GOVERNMENT TO DISCONTINUE ITS
 DECISION TO RESUME NUCLEAR TESTING, AND CALLING ALL EARTHLOVING
 PEOPLE TO JOIN IN THE WORLDWIDE MOVE TO STOP ALL FORMS OF NUCLEAR
 TESTING.

WHEREAS, the French government has decided to resume a
 series of nuclear testing in the South Pacific Isle of Mururoa
 Atoll starting in the month of September 1995;

WHEREAS, several countries such as the United States of
 America, Britain, Japan, Australia and the Asean countries aired
 their concern on the horrifying effects of nuclear radiation
 while people from all walks of life worldwide joined the mass
 protest and condemnation against all forms of nuclear test.
 WHEREAS, the radiation emitted from the explosion of nuclear
 bombs will contaminate sea waters, fish and aquatic resources and
 destroy our environment which in turn will threaten man's
 survival on earth.

WHEREAS, the resumption of nuclear testing will surely
 create an atmosphere of global threat on peace, security and
 safety among all nations particularly in the Asia-Pacific region.
 WHEREAS, the nuclear holocaust in Hiroshima and Nagasaki,
 Japan was so devastating that it caused the death of about
 300,000 Japanese people.

WHEREAS, in order to preserve mankind from the horrifying
 effects of nuclear weapons, the Sangguniang Panlungsod of
 Muntinlupa appeals to the French government to discontinue the
 resumption of nuclear test in the South Pacific Isle of Mururoa
 Atoll, and calls for a stoppage of all forms of nuclear tests.

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the
 Sangguniang Panlungsod of Muntinlupa appeals to the French
 government to discontinue the resumption of nuclear tests at the
 South-Pacific Isle of Mururoa Atoll and strongly demands for a
 stoppage of all forms of nuclear testing;


