WHEREAS, there are thousands of the people of Muntinlupa City who have applied for telephone connection. As of this date, however, they have no telephone yet;

WHEREAS, their applications have been long pending in the offices of the PLDT without being acted upon despite the implementation of the corporation's zero backlog project;

WHEREAS, the telephone applicants have been clamoring for immediate installation of their telephones;

WHEREAS, the installation of telephones will help decongest the worsening traffic condition as those with telephones will no longer go to the places where they have transactions because they can already use their telephones and will help minimize their expenses for gasolines and transportation fares;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Panlungsod of Muntinlupa requests the Philippine Long Distance Telephone Company (PLDT) to expedite the installation of telephones to all applicants for telephone connection in the City of Muntinlupa.

BE IT FURTHER RESOLVED, AS IT IS HEREBY RESOLVED, that copy of this resolution be furnished the President/Chairman of the Board of the Philippine Long Distance Telephone Company.






