A RESOLUTION URGING MAYOR IGNACIO R. BUNYE TO DIRECT THE CITY TREASURER TO COLLECT THE ONE PERCENT (1%) SHARE OF THE CITY GOVERNMENT OF MUNTINLUPA IN THE PROCEEDS OF THE DEVELOPMENT AND UTILIZATION OF THE ALABANG STOCK FARM FROM THE PUBLIC ESTATES AUTHORITY AND THE DEPARTMENT OF BUDGET AND MANAGEMENT.

WHEREAS, the Local Government Code under Section 289 provides that "Local Government Units shall have an equitable share in the proceeds derived from the utilization and development of the national wealth within their respective areas, including sharing the same with the inhabitants by way of direct benefits;

WHEREAS, specifically under Section 291, Local Government units are entitled to a one percent (1%) share in the gross proceeds derived by any government agency or government-owned or controlled corporation engaged in the utilization and development of the national wealth;

WHEREAS, under Article 386 of the Implementing Rules and Regulations of the Local Government Code, national wealth is defined as all natural resources situated within the Philippine Territory which includes among other lands of Public domain;

WHEREAS, the Public Estate Authority has entered into a Joint Venture Agreement with the Filinvest Development Corporation for the development of Alabang Stock Farm;

WHEREAS, the City Government is entitled to a share in the proceeds of the development of the Alabang Stock Farm since the natural resource being developed is a parcel of land of the public domain situated within the territory of the City of Muntinlupa;

WHEREAS, the City Government must undertake the collection of its share in the development of the Alabang Stock Farm from the Public Estates Authority in order to take advantage of the benefits under the Local Government Code and to maximize the inflow of funds to the City coffers.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa to urge Mayor Ignacio R. Bunye to direct the City Treasurer to collect the one percent (1%) share of the City Government of Muntinlupa in the proceeds of the development and utilization of the Alabang Stock Farm from the Public Estates Authority and the Department of Budget and Management.
