WHEREAS, the LAGUNA LAKE DEVELOPMENT AUTHORITY is reducing the area of waters for fishpen purposes from 3,200 to 1,800 hectares only;

WHEREAS, the reduction of the area of waters for fishpen purposes will greatly affect the fishpen owners/operators residing in Muntinlupa City to their prejudice in particular and the City of Muntinlupa in general;

WHEREAS, as residents of the City of Muntinlupa, they deserve not to be deprived of having fishpens in the territorial water in Laguna de Bay within the jurisdiction of the City;

WHEREAS, the fishpen operators residing in Muntinlupa City who applied for permit in the Laguna Lake Development Authority are placed in the third priority only;

NOW THEREFORE, BE IT RESOLVED, AS IT IS RESOLVED, that the Sangguniang Panglungsod of Muntinlupa City hereby urges/requests the Laguna Lake Development Authority to grant permit to operate fishpen within the territorial waters of the City of Muntinlupa first to applicants residing in the City of Muntinlupa.

BE IT FURTHER RESOLVED, that copy of this resolution be immediately furnished the General Manager of the Laguna Lake Development Authority and Mt. Makiling and Laguna Lake Commission.
