WHEREAS, it is provided under Section 7 of Republic Act No. 7432 otherwise known as An act to maximize the contribution of Senior Citizen to Nation Building, grant benefits and special privileges and for other purposes that:

"There shall be established in the Office of the Mayor an OSCA to be headed by a Councilor, who shall be designated by the Sangguniang Bayan and assisted by the Community Development Officer in coordination with the Department of Social Welfare and Development."

WHEREAS, a resolution was approved renaming the Office of the Senior Citizens Affairs into Office of the Senior Citizens Affairs, Veterans, Retirees and Disabled Persons;
