RESOLUTION NO 96-271

RESOLUTION ALLOWING THE NATIONAL POWER CORPORATION TO INSTALL STEEL POLES ALONG THE PHILIPPINE NATIONAL RAILWAYS FROM SUCAT TO TUNASAN, MUNTINLUPA CITY.

WHEREAS, the PNR and NPC have a Right of Way Agreement executed on August 13, 1995 where the latter is given the right of way for the construction/erection/operation and maintenance of 79 tabular steel poles and 2 steel towers in Sucat-Balintawak 230 KV Transmission Line, and 74 tabular steel poles in the Binan-Sucacat 230 KV Transmission Line Project ;

WHEREAS, from Sucat to Tunasan, Muntinlupa City, 70 poles will be constructed. The height of each pole is 36.5 meters and the height of the transmission lines to be placed is 23 meters;

WHEREAS, the 70 households from Sucat to Tunasan who will be affected by the project were already paid;

WHEREAS, all the Barangay Captains from Sucat to Tunasan have already issued clearances indicating therein that they have no objection to the installation of the poles;

WHEREAS, the installation of the poles by NPC will be at the end of March, 1996 only;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NAPOCOR be allowed to erect/install/construct the steel poles along the PNR from Sucat to Tunasan, Muntinlupa City;

BE IT RESOLVED FURTHER, AS IT IS HEREBY RESOLVED, that this authority which is given to the NPC is without prejudice to the right to claim for damages or reimbursement of expenses of the affected homeowners and occupants with the NPC.

This Resolution shall take effect immediately.

ADOPTED by the Sangguniang Panglungsod of Muntinlupa this 11th day of March, 1996, City of Muntinlupa on the 32nd regular session.


