BUNYE TO DIRECT THE CITY ENGINEER'S OFFICE, CHIEF OF THE MUNTINLUPA FIRE STATION AND OTHER CONCERNED OFFICES TO CONDUCT AN IMMEDIATE INSPECTION OF ALL COMMERCIAL ESTABLISHMENT TO DETERMINE IF THEY COMPLY WITH ALL THE SAFETY PROVISIONS MANDATED UNDER THE NATIONAL BUILDING CODE.

**WHEREAS**, the catastrophe that happened in Quezon City last March 18, 1996 which caused the death of 157 people and injuries to others as a result of the burning of the Ozone Disco House needs an immediate act on the part of the City Government of Muntinlupa in order to avoid a similar occurrence in our City;

**WHEREAS**, based on reports, the Ozone incident was due to laxities of some concerned agencies of the government to perform their routine duties of conducting periodic inspections to determine compliance by the building owners of their obligations under the National Building Code;

**WHEREAS**, it was also found out that there were inadequacies in the safety features of the building like the absence of proper exit doors in case of emergency and absence of fire extinguishers;

**WHEREAS**, in order to insure the safety of our people while inside the commercial establishments, theaters, hospitals and other infrastructures, there is a need for an immediate inspection by our concerned offices in the city government on said establishments;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to request the City Mayor of Muntinlupa to direct the City Engineer, Chief of Fire Station and other offices to immediately conduct an inspection of the commercial establishments in the City of Muntinlupa to find out if there are safety features in accordance with the National Building Code;

**ADOPTED**, by the Sangguniang Panglungsod of Muntinlupa this 25th day of March, 1996, on the 34th Regular Session.
