WHEREAS, the City of Muntinlupa has one (1) Metropolitan Trial Court and two (2) Regional Trial Courts;

WHEREAS, due to the expanded jurisdiction of the Metropolitan Trial Courts and the creation of the City Prosecutor's Office in the City of Muntinlupa, there is a marked rise in the average number of cases which are filed before the lone Metropolitan Trial Court;

WHEREAS, there are more than One Hundred Sixty (160) cases filed monthly before the lone Metropolitan Trial Court and more than Three Thousand (3,000) cases are now pending in said Metropolitan Trial Court;

WHEREAS, the court calendar of the Metropolitan Trial Court shows that there are thirty (30) cases on its daily schedule which is one of the causes of delay in the speedy disposition of cases in said court;

WHEREAS, in line with the announced policy of reform in the judicial system and adherence to the adage that justice delayed is justice denied, it is but proper that the sala of the Metropolitan Trial Court of the City of Muntinlupa be increased by creating an additional two (2) salas:

WHEREAS, the City Government of Muntinlupa has an Annex Building, which is being constructed where the two (2) Salas can be temporarily accomodated pending the construction by the Department of Justice of the Muntinlupa City Hall of Justice;

WHEREAS, the City Government may provide augmentation employees as will be needed by the additional courts to be created;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Panglungsod of Muntinlupa hereby requests the Supreme Court of the Philippines to create additional two (2) Metropolitan Trial Court Salas in the City of Muntinlupa;

ADOPTED by the Sangguniang Panglungsod of Muntinlupa this 13th day of May, 1996 in the City of Muntinlupa on its 38th Regular Session.




