RESOLUTION NO. 96-288

RESOLUTION URGING THE CITY GOVERNMENT OF MUNTINLUPA THRU THE HONORABLE MAYOR IGNACIO R. BUNYE AND THE CITY TREASURER TO EFFECT THE DISTRIBUTION OF THE 35% SHARE OF THE NINE (9) COMPONENT BARANGAYS OF THE CITY FROM THE COLLECTION OF THE ONE (1%) PERCENT SHARE OF THE CITY OF MUNTINLUPA IN THE PROCEEDS DERIVED FROM THE DEVELOPMENT AND UTILIZATION OF THE ALABANG STOCK FARM.

WHEREAS, the City Council of Muntinlupa has approved Sangguniang Panglungsod Resolution No. 96-259 last February 05, 1996 "Urging Mayor Ignacio R. Bunye to direct the City Treasurer to collect the One (1%) percent share of the City Government of Muntinlupa in the proceeds derived from the development and utilization of the Alabang Stock Farm from the Public Estates Authority and the Department of Budget and Management;"

WHEREAS, the Local Government Code under Section 289 provides that "Local Government Units shall have an equitable share in the proceeds derived from the utilization and development of the national wealth within their respective areas, including sharing the same with the inhabitants by way of direct benefits;"

WHEREAS, specifically under Section 291. "Local Government Units are entitled to a One (1%) percent share in the gross proceeds derived by any government agency or government-owned or controlled corporation engaged in the utilization and development of the national wealth;"

WHEREAS, under Article 387 (b) of the Implementing Rules and Regulations of the Local Government Code, national wealth is defined as all natural resources situated within the Philippine Territory which includes among other lands of Public Domain:

WHEREAS, the Public Estates Authority has entered into a Joint Venture agreement with Filinvest Development Corporation for the development of the Alabang Stock Farm:

WHEREAS, the City of Muntinlupa is entitled to a share in the proceeds of the development of the Alabang Stock Farm since the natural resources being developed is a parcel of land of the public domain situated within the territory of the City of Muntinlupa;

WHEREAS, the City Government of Muntinlupa shall undertake the collection of its One (1%) percent share in the proceeds of the development of the Alabang Stock Farm from the Public Estates Authority in order to take advantage of the benefits under the Local Government Code and to maximize the inflow of funds to the City coffers:

WHEREAS, Article 389 (b) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that the allocation of shares in the foregoing proceeds shall be Sixty Five (65%) percent to the City and Thirty Five (35%) percent to the Barangays:

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa to urge the City Government of Muntinlupa through the Hon. Mayor Ignacio R. Bunye and the City Treasurer to effect the distribution of the 35% share of the nine (9) component Barangays of the City from the collection of the One (1%) percent share of the City of Muntinlupa in the proceeds from the development and utilization of the Alabang Stock Farm.

ADOPTED by the Sangguniang Panglungsod of Muntinlupa this 10th day of June in the City of Muntinlupa on its 42nd Regular Session.






