RESOLUTION NO. 96-292

A RESOLUTION INDORSING THE REQUEST OF THE ASSOCIATION OF BARANGAY CAPTAIN (ABC) TO THE HONORABLE SENATE PRESIDENT, SENATOR NEPTALI GONZALES, TO ALLOCATE AND FINANCE FROM HIS COUNTRYWIDE DEVELOPMENT FUND (CDF) THE CONSTRUCTION OF 20,000 GALLONS ELEVATED WATER TANK INCLUDING PUMPHOUSE, DEEPWELL PUMP, BOOSTER PUMP AND WATER DISTRIBUTION SYSTEM IN THE BARANGAYS OF MUNTINLUPA CITY.

WHEREAS, section 16 of the Local Government Code of 1991 states that "every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their territorial jurisdiction, Local Government Units shall ensure and support, among other things xxx, promote health and safety, enhance prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;"

WHEREAS, section 17 (b) (1) (v), of the Local Government Code of 1991 further states that "Local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein such as the maintenance of barangay roads and bridges and water supply systems:"

WHEREAS, the existing water system of the City of Muntinlupa is insufficient to meek the peek hour demand of its constituents due to inadequate source and the absence of a minimum water storage:

WHEREAS, there is a great need to install an elevated water tank for all the barangay in Muntinlupa since water is an important necessity and basic commodity for every household especially in time of emergencies such as fire;

WHEREAS, the construction and installation of the water tank shall induce and create employment in the area where the proposed project will be constructed or installed;

WHEREAS, adequate water supply will improve the quality of life for the residents making life much easier;

WHEREAS, the barangays shall manage and operate the said project and shall provide them the additional income for their barangays to finance their future projects:

WHEREAS, the Association of Barangay Captain (ABC) of Muntinlupa in its regular monthly meeting held last August, 1995 unanimously approved the project requesting the Honorable Senate President, Neptali Gonzales, to allocate the necessary amount for the construction of a 20,000 gallons of water tank with pumphouse, deepwell pump, booster pump and water distribution system:

WHEREAS, per letter of Engr. Alfredo A. Vinalon addressed to Atty. Jaime R. Fresnedi, City Vice Mayor, thru Councilor Patricio L. Boncayao, Jr. on May 15, 1996 the amount needed is P4,200,000.00 as shown in the cost estimate/bill of materials hereto attached as Annex "A";

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa that Hon. Senate President Neptali Gonzales, be requested to allocate P4,200,000.00 to finance the construction of 20,000 gallons elevated water tank including pumphouse, deepwell pump, booster pump and water distribution system in the barangays of Muntinlupa City.
