	WHEREAS, in order to ensure safe and adequate nutrition for infants, the President of the Philippines issued Executive Order No. 51 to protect and promote breast-feeding and to inform the public about the proper use of breastmilk substitutes and supplements and related products through adequate, consistent and objective information of said substitutes, supplement and related products:	
	WHEREAS, the Code covers the marketing and practices related to breastmilk substitutes, infant formula, milk products, foos and beverages, bottlefed complementary foods when marketed or otherwise represented to be suitable for use as a partial or total replacement of breastmilk, feeding bottles and teats:	
\	WHEREAS, said code fully encourages the promotion of breat infants due to its natural content of all the nutrients and antibodies a not growth and development; purity and cleanliness of breastmilk; and the nature mother and child during breastfeeding:	ewborn baby needs for its full
	WHEREAS, the City Government of Muntinlupa is aware that the use of improper and artificial feeding practices are considered as one of the causes of infant mortality and that there is a need to control and regulate the production, manufacture, use, distribution and sale of said breastmilk substitutes;
