WHEREAS, Section 2 of Article XIV of the 1987 Constitution provides that, "it is the duty of the State to establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society;"

WHEREAS, in line with the President's vision of Quality Education Through Philippines 2000, all members of the Sangguniang Panglungsod of Muntinlupa firmly recognize the importance of providing educational materials to all public schools of Muntinlupa City for the purpose of uplifting the intellectual and social well-being of its youth as the direct beneficiary.




