RESOLUTION REQUESTING THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) TO EXEMPT THE CITY OF MUNTINLUPA FROM THE COVERAGE OF THE UNIFIED VEHICULAR VOLUME REDUCTION PROGRAM UNDER MMDA REGULATION NO. 96-005.

WHEREAS, the Unified Vehicular Reduction Program of the Metropolitan Manila Development Authority (MMDA) under MMDA Regulation No. 96-005 prohibits the operation of private and public motor vehicles on all national, city and municipal roads within the territorial jurisdiction of Metropolitan Manila on specific days depending on the plate number endings:

WHEREAS, the City of Muntinlupa is adjacent to the provinces of Laguna and Cavite whose municipalities are rapidly growing and developed as industrial estates and sites for factories and manufacturing companies:

WHEREAS, the implementation of the Unified Vehicular Volume Reduction Program in the City of Muntinlupa restricted the movements of workers, businessman and market vendors in going to and from their residence to their respective places of work or business in the City of Muntinlupa and the adjacent towns of the provinces of Laguna and Cavite:

WHEREAS, said vehicle reduction program is unduly affecting the economic progress of Muntinlupa as a new city and that prospective investors may shift to nearby Laguna and Cavite:

WHEREAS, the exemption of the City of Muntinlupa from the coverage of MMDA Regulation No. 96-005 will not cause monstrous traffic jams or exacerbate the traffic situation within the City:

WHEREAS, in order to accelerate the economic growth of the City of Muntinlupa before the year 2000, the Sangguniang Panglungsod unanimously agreed that Muntinlupa City be exempted from the coverage of the Unified Vehicular Volume Reduction Program under MMDA Regulation No.96-005:

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa to request the Metropolitan Manila Development Authority to amend MMDA Regulation No. 96-005 by exempting the City of Muntinlupa from the coverage of the Vehicular Volume Reduction Program.

ADOPTED by the Sangguniang Panglungsod of Muntinlupa this 16th day of September, 1996 on its 55th Regular Session.


