RESOLUTION AUTHORIZING MAYOR IGNACIO R. BUNYE TO SIGN THE MEMORANDUM OF AGREEMENT WITH INSULAR LIFE ASSURANCE CO. LTD. FOR THE LIFE INSURANCE COVERAGE OF EMPLOYEES IN THE CITY GOVERNMENT OF MUNTINLUPA CITY.

WHEREAS, Insular Life Assurance Co. Ltd. desires to offer its life insurance program to the local and national employees of the City Government of Muntinlupa;

WHEREAS, this project will be on a voluntary basis but the payment of the monthly premium shall be through a payroll deduction scheme subject to a written authorization from the insured;

WHEREAS, the amounts to be deducted from the monthly salary of the insured shall be remitted to Insular Life Assurance Co. Ltd.;

WHEREAS, the Memorandum of Agreement has been reviewed and found to be in accordance with applicable laws and that it is beneficial to the government and the employees;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Panglungsod to authorize Mayor Ignacio R. Bunye to sign the Memorandum of Agreement between the City Government of Muntinlupa and Insular Life Assurance Co. Ltd.


