RESOLUTION NO. 96-331 RESOLUTION AUTHORIZING MAYOR IGNACIO R. BUNYE TO ENTER AND SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND S.M. GROUP INTERNATIONAL INC. OF CANADA FOR THE WATER TREATMENT AND WATER SUPPLY PROJECTS OF MUNTINLUPA CITY Sponsored by : All Sangguniang Panglungsod Members ******************** WHEREAS, researches and studies conducted on the causes of fishkills in the Laguna de Bay show that the pollution of the lake is due to the dumping of waste materials and liquids along the creeks and rivers within the territorial area of Muntinlupa City and the adjoining towns and cities: WHEREAS, it was also found out that some if not all the industrial and manufacturing firms have no waste water treatment facilities or waste materials disposal system; WHEREAS, studies also showed that the subterranean water level in Muntinlupa City is going deeper and it is envisioned that in the near future, the City of Muntinlupa will experience a water crisis: WHEREAS, there is a need to conduct a feasibility study to identify the requirements of establishing a waste water treatment/management facility and providing sufficient water for the industrial. commercial and residential requirements of the City of Muntinlupa by identifying the water sources WHEREAS, S.M. GROUP INTERNATIONAL INC. OF CANADA is willing to participate and assist in the program of the City Government of Muntinlupa in identifying the requirements of establishing a waste water treatment/management facility and the sourcing of potable water to supply the needs of the residents of Muntinlupa City; WHEREAS, pursuant to Republic Act 7160 otherwise known as the Local Government Code. the City Council is mandated to review and approve all contracts which the City Mayor shall enter into for and in behalf of the City Government; WHEREAS, the City Council of Muntinlupa is willing to authorize the City Mayor. Hon. Ignacio R. Bunye to sign a Memorandum of Understanding between the City government of Muntinlupa and S.M. Group International Inc. of Canada for the prefeasibility and feasibility study of the waste water treatment/management facility to be established in the City of Muntinlupa and for the sourcing of water to supply the requirements of the residents of Muntinlupa City subject to the condition that the agreement will not be exclusive in nature; it will not bind the City Government; that other proponents may still be considered; that no government funds will be involved; and that the City Government shall not be obliged or committed to source local or foreign financing. NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the angguniang Panglungsod of Muntinlupa to authorize Mayor Ignacio R. Bunye to sign a Memorandum of Inderstanding between the City of Muntinlupa and S.M. GROUP INTERNATIONAL INC. OF CANADA to conduct a prefeasibility and feasibility study for the waste water treatment and water supply requirements of the City of Muntinlupa subject to compliance of the above conditions. ADOPTED by the Sangguniang Panglungsod of Muntinlupa this 2nd day of December. 1996 in the City of Muntinlupa on its 64th Regular Session.
