A RESOLUTION GIVING THE CITY MAYOR, HON. IGNACIO R. BUNYE AUTHORITY TO ENTER INTO A SUPPLEMENTAL AGREEMENT WITH VIC VERA BUILDERS, INC., FOR THE PROJECT, PROPOSED ROAD ASPHALTING, PHASE II, AT DON JUAN BAYVIEW SUBDIVISION, SUCAT, MUNTINLUPA CITY.

WHEREAS, the roads in Don Juan Bayview , in view of the on-going construction of the Skyway, are being used as alternate routes of vehicles coming from Bagumbayan to the Expressway and vice-versa;

WHEREAS, last August 18, 1997 , said roads were heavily damaged because of heavy rains and typhoon that passed the country. The heavy rains caused strong floods that carved out the soil and damaged the asphalts rendering the said roads impassable;

WHEREAS, there is an on-going Project (Road Asphaltting) in the said area with a budget of Two Million Eight Hundred Eight Thousand Five Hundred Twenty Two Pesos and 90/100 (P2,808,522.90), said amount is not sufficient to asphalt all the damaged roads;

WHEREAS, there was a previous declaration from the President that Metro Manila was under a Calamity Area by reason of the heavy rains, floods and typhoon that passed over the country;

WHEREAS, on 8 December 1997, the Sangguniang Panglungsod of Muntinlupa, on its 108th Regular Session, approved Ordinance No. 97-35 which provide for the allocation of additional amount of Three Million Pesos (P3,000,000.00) for the project;






