WHEREAS, the homeowners of Lakeview II, Putatan, Muntinlupa City requested last year the City Government for the concreting of their roads;

WHEREAS, the Engineering Office submitted Bill of Materials with a total estimated cost of P1,350,000.00 for road constructions of about 349 meters;

WHEREAS, there are Certification and Request for Obligation of Allotment where P1,350,000.00 is available under the so called continuing appropriation to fund the project;

WHEREAS, the Resolution of the PBAC dated June 26, 1996 showed that a bidding was held and that Sellhica Construction won the bid;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the City Mayor Ignacio R. Bunye be authorized to enter into a contract with the Sellhica Construction for the concreting of the 349 meters road in Lakeview II, Putatan, Muntinlupa City.
