WHEREAS, the Manuela Corporation is going to construct a drainage system in front of the Metropolis along the National Highway to the Bank of the Philippine Island, in Barangay Alabang;

WHEREAS, the drainage system is urgently necessary to prevent floods during rainy season;

WHEREAS, the drainage system is about 165 meters in length and the concrete pipe to be used has a diameter of 36 inches;

WHEREAS, the construction of the drainage system shall be financed solely by the Manuela Corporation and that no government fund shall be used;

WHEREAS, the construction shall be under the supervision of the Engineering Department of the City and that the Corporation shall comply with the necessary construction permit;

WHEREAS, the Corporation shall see to it that the construction shall not cause traffic congestion in Alabang.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod to authorize the Manuela Corporation to construct a drainage system along the National Highway in front of the Metropolis up to the Bank of the Philippine Island, Alabang, Muntinlupa City.
