RESOLUTION REQUESTING CONGRESSMAN ROLANDO ANDAYA TO SET ASIDE FROM HIS CONGRESSIONAL DEVELOPMENT FUND THE AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND (P2,500,000.00) PESOS FOR THE CONSTRUCTION OF TEN (10) UNITS OF DEEPWELL WITH MOTOR AND ELEVATED WATER TANK IN THE CITY OF MUNTINLUPA.

WHEREAS, there is an urgent need in the City of Muntinlupa to construct deep-wells for the water requirements of the residents thereat in view of the absence of water sources from the Metropolitan Waterworks and Sewerage System (MWSS);

WHEREAS, as a new City, the estimated income and budget of the City of Muntinlupa is not yet sufficient to satisfy the water requirements of the residents:

WHEREAS, there is a need to source additional funds for this project and augment the financial needs of the City Government by soliciting assistance from benevolent citizens and officials of the National Government particularly the House of Representatives:

WHEREAS, Congressman Rolando Andaya is well known for his concern on the plight of Local Government Units and in giving financial assistance from his congressional development fund for projects involving the basic needs of the citizens:

WHEREAS, the Sangguniang Panglungsod of Muntinlupa City in its desire to provide water services to the residents deem it appropriate to seek the assistance of Congressman Rolando Andaya by providing the City Government of Muntinlupa the amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00) for the construction of ten (10) units deep-well complete with a motor and elevated water tank for each water system:

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request Congressman Rolando Andaya to set aside from his congressional development fund the amount of TWO MILLION FIVE HUNDRED THOUSAND PESOS (P2,500,000.00) as financial assistance to the City Government of Muntinlupa for the purpose of constructing ten (10) units deep-well water systems complete with motor and elevated water tank at a cost of Two Hundred Fifty Thousand Pesos (P250,000.00) each system.






