RESOLUTION NO. 97-28

A RESOLUTION GIVING THE CITY MAYOR, HON. IGNACIO R. BUNYE AN AUTHORITY TO ENTER INTO A CONTRACT WITH AESTHETIC CONSTRUCTION AND TRADING FOR THE RENOVATION OF THE FISCAL'S OFFICE, LOCATED AT NATIONAL ROAD, PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION THREE HUNDRED THIRTY SIX THOUSAND FIVE HUNDRED FORTY ONE PESOS (P1,336,541.00).

WHEREAS, on October 30, 1996, the Hon. Mayor Ignacio R. Bunye, sent a letter request to the Sangguniang Panglungsod thru Vice-Mayor Jaime R. Fresnedi for authority to enter into a contract with the **Aesthetic Construction and Trading** for the **Renovation** of the Fiscal's Office located at National Road, Putatan, Muntinlupa City;

WHEREAS, during the public hearing, the Committee received the Resolution of the Pre-qualification, Bid and Award Committee indicating that Aesthetic Construction and Trading won the bid;

WHEREAS, the renovation of the Fiscal's Office has a cost estimate of **One Million Three Hundred Thirty Six Thousand Five Hundred Forty One Pesos (P1,336,541.00)**.

WHEREAS, there is a budget allocated for this project under the so called continuing appropriation per **Request of Obligation of Allotment No. 010137040237**;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved that the **City Mayor** be given the **authority** to enter into a contract with Aesthetic Construction and Trading for the renovation of the Fiscal's Office, located at National Road Putatan, Muntinlupa City in the amount of **One Million Three Hundred Thirty Six Thousand Five Hundred Forty One Pesos (P1,336,541.00)**.
