	WHEREAS, on 14 April 1997, about thirty one (31) houses at the Gundran Compound and Esporlas Compound in Barangay Putatan. Muntinlupa City were burned and razed to the ground affecting about more or less eighty one (81) families:	1
	WHEREAS, the fire victims are temporarily housed in a school and other buildings nearby.	
	WHEREAS, the said fire has caused extreme distress, misfortune, loss of property, starvation and health problems to the affected families;	_
	WHEREAS, pursuant to Republic Act No. 8185 amending Section 324 (d) of Republic Act No. 7160, five (5%) per cent of the estimated revenue from regular sources shall be set aside as annual lump sum appropriations for relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year;	
	WHEREAS, pursuant to said amendatory law such fund shall be used only in the area or portion of the Local Government Unit or areas affected by a disaster or calamity as determined and declared by the Local Sanggunian concerned:	
	WHEREAS, calamity as defined in said law is "a state of extreme distress or misfortune produced by adverse circumstances or event or any great misfortune or cause or loss or misery caused by natural forces:"	60
	WHEREAS, in case of fire or conflagration, the calamity fund shall be utilized only for relief operations:	18
	WHEREAS, the occurrence of the fire/conflagration at the Gundran and Esporlas Compound in Barangay Putatan. Muntinlupa City which affected about eighty one (81) families was contained in a report of the Muntinlupa City Fire Marshall dated 14 April 1997:	
	WHEREAS, the Sangguniang Panglungsod of Muntinlupa City deems it proper and necessary to declare the area covered by Gundran and Esporlas compound in Barangay Putatan. Muntinlupa City as a calamity area in accordance with Republic Act 7160 as amended by Republic Act 8185 and that Mayor Ignacio R. Bunye is hereby authorized to released from the calamity fund of the City Government such amount as will be necessary to support the relief operations thereat:	nan
Mar	NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod to declare the Gundran and Esporlas compound in Barangay Putatan. Muntinlupa City as a calamity area pursuant to RA 7160 as amended by RA 8185, resolved further to authorize Mayor Ignacio R. Bunye to release such amount as are necessary for the relief operations to be conducted thereat.	100
