RESOLUTION GIVING AN AUTHORITY TO THE CITY MAYOR, IGNACIO R. BUNYE TO ENTER INTO A SUPPLEMENTAL AGREEMENT WITH THE F.S.A. CONSTRUCTION FOR THE ADDITIONAL WORKS/VARIATION ORDER OF THE ROAD CONCRETING AT THE NIA ROAD, PUTATAN, MUNTINLUPA CITY.

WHEREAS, on March 12, 1997 the City Mayor, Hon. Ignacio R. Bunye requested the City Council thru a letter addressed to the Vice Mayor, Hon. Jaime R. Fresnedi for authority to enter a Supplemental Agreement with the F.S.A. Construction.

WHEREAS, the F.S.A. project construction was awarded with the Road Concreting at the NIA Putatan after it won the Public Bidding on March 17, 1995;

WHEREAS, based on the original plan the road concreting would pass through the middle portion of the lot of Mrs. Maria Moldez, to prevent the division of the lot. So said owner requested that the road concreting should just be made at the side end portion of the lot.

WHEREAS, the concreting of the road from the original plan (middle portion) to the side end portion of the lot requires additional cost of materials and labor amounting to Five Hundred Twenty Eight thousand, Seventeen Pesos (P528,017.58) per bill of materials and letter to the Hon. Mayor Ignacio R. Bunye sent by Engr. Eduardo Bautista of the Engineering's Office.

WHEREAS, there is a budget in the amount of Five Hundred Twenty Eight Thousand Seventeen Pesos (P528,017.00) per Request for Obligation of Allotment No. 01017020572 and Certification for the project;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the Hon. City Mayor Ignacio R. Bunye be allowed to enter into a Supplemental Agreement with F.S.A. Construction for the additional work of the road concreting at NIA Road, Putatan, Muntinlupa City.
