WHEREAS, the Principal, Isabelita L. Montessa of the Muntinlupa National High School thru a letter dated November 17, 1995 to the Hon. Mayor Ignacio R. Bunye requested for the immediate repair of the school facilities caused by typhoon Rosing;

WHEREAS, the repair was urgently necessary so as not to dislocate students and disrupt the studies of the students;

WHEREAS, per bill of materials the amount needed for the repair was SEVEN HUNDRED EIGHTY THOUSAND THREE HUNDRED NINETY SEVEN AND 51/100 PESOS (P780,397.51) and that there was an amount allocated for the project from the FIVE (5) PERCENT Calamity Fund for 1996 as shown in the Request for Obligation of Allotment No. 010196050984;

WHEREAS, the project was an emergency and undertaken pursuant to the two (2) conditions set forth in P.D. 1594 which read :

- b. In an emergency situation where immediate action is necessary to preclude the possibility of disruption of basic public service and undue inconvenience to the general public, and
- c. In times of emergencies arising from natural calamities where immediate and urgent action is necessary to prevent imminent loss of life and property.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the repair of the damaged facilities of the National High School, Muntinlupa City by R.L. Parong Builders be confirmed and ratified.
