WHEREAS, upon representation of the residents of Sitio Pagkakaisa in Barangay Sucat, Muntinlupa City and endorsed by the Sangguniang Barangay of Sucat, Muntinlupa City, the establishment and creation of an Annex Building for Sucat Elementary School was approved by the Department of Education Culture and Sports:

WHEREAS, a torn-out and dilapidated private house surrounded by residential houses in Sitio Pagkakaisa was temporarily rented and used as an Annex Building of Sucat Elementary School:

WHEREAS, it was discovered that the dilapidated condition of the schoolhouse annex and its location is not conducive to provide quality education and has seriously affected the learning process of the children:

WHEREAS, there is an urgent need to transfer the schoolhouse annex from its present site to another area within Sitio Pagkakaisa, Barangay Sucat, Muntinlupa City:

WHEREAS, it was established that a portion of a wide tract of land in Sitio Pagkakaisa which is owned by Congressman Manuel B. Villar, Jr. can be use as a school site for the construction of a school building:

WHEREAS, the Sangguniang Barangay of Sucat, Muntinlupa City passed Resolution No. 10 dated 12 August 1996 requesting Congressman Manuel B. Villar, Jr. to allocate and donate an area of **Five Hundred (500) square meters** of his property in Sitio Pagkakaisa, Barangay Sucat, Muntinlupa City to be used as a school site for the construction of a school building as an Annex to Sucat Elementary School.
