WHEREAS, the Hon. Mayor Ignacio R. Bunye thru a letter dated November 4, 1996 requested the City Council to ratify forty-seven (47) infrastructure projects implemented and completed during the Fiscal Year, 1995:

WHEREAS, of the forty-seven (47) infrastructure projects which were entered into by the Hon. City Mayor Ignacio R. Bunye with accredited and qualified contractors of the City Government of Muntinlupa, fifteen (15) were negotiated contracts:

WHEREAS, the contracts were transmitted to the Sangguniang Panglungsod for the purpose of ratification/confirmation as required by the Local Government Code of 1991 and its implementing rules and regulations:

WHEREAS, the fifteen (15) projects were all satisfactorily completed in accordance with the approved plans and specification as per Certification dated January 14, 1997 issued by the City Engineering's Office and noted by Auditor of the COA:

WHEREAS, eleven (11) of the fifteen (15) contracts were undertaken in accordance with all the conditions setforth in P.D. 1594, herein quoted:

"a. Where the project is adjacent or contiguous to an ongoing project and it could be economically prosecuted by the same contractor, in which case negotiation may be undertaken with the same contractor at the same unit price, less mobilization cost provided he has no negative slippage and has demonstrated satisfactory performance as provided for in P.D. 1594.

- b. In emergency situation where immediate action is necessary to preclude the possibility of disruption of basic public service and of undue inconvenience to the general public.
- c. In times of emergencies arising from natural calamities where immediate and urgent action is necessary to prevent imminent loss of life and property."

WHEREAS, two (2) of the fifteen (15) projects were purchase contracts where the implementation for the supply of fabricated construction materials complied with the Commission on Audit Resolution No. 95-244:

WHEREAS, one (1) contract was the emergency repair of Susana Heights Street and one (1) contract was the emergency construction of the Muntinlupa Polytechnic College as per justification submitted by the Engineering's Office and letter dated January 22, 1997 address to the Vice-Mayor submitted by the City Attorney's Office, the legal opinion contains the following recommendations:

"Based on the foregoing, it is respectfully submitted that the Sangguniang Panglungsod has the power, authority and legal basis in ratifying the said infrastructure projects."

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod to ratify/ confirm the fifteen (15) negotiated projects attached to the letter request dated November 4, 1996 of the Hon. City Mayor Ignacio R. Bunye and listed in the letter of City Attorney Raul Corro to Hon. Jaime R. Fresnedi containing the justification of the implementation of the projects hereto attached.
