RESOLUTION AUTHORIZING THE CITY MAYOR, HON. IGNACIO R. BUNYE TO ENTER INTO A SUPPLEMENTAL AGREEMENT WITH D. L. CERVANTES CONSTRUCTION FOR THE CHANGE ORDER / ADDITIONAL WORK IN THE ON-GOING PROJECT, "CITY HALL ANNEX."

WHEREAS, on 19 April 1996 the City Council authorized the City Mayor, Hon. Ignacio R. Bunye to enter into a contract with D. L. Cervantes Construction for the construction of the "City Hall Annex Building" thru Resolution Number 96-285;

WHEREAS, the construction of the City Hall Annex has an allocated budget of P15,000,000.00 but the approved contract cost amounted only to P13,892,178.00. Hence, there is a difference of P1,107,822.00;

WHEREAS, the City Hall Annex is now under construction. The Engineering's Office has found out to make use of the space at the back of the building. Hence, a change order or additional work is necessary;

WHEREAS, the change order or additional work is 60 square meters per floor or a total of 240 square meters;

WHEREAS, the amount needed is P1,105,484.12 for the said change order or additional work. The price per square meter is lower than the cost per square meter as compared to the on-going construction;

WHEREAS, the amount of P1,105,484.12 to be use for such additional work shall be taken from the savings in the fifteen million (P15,000,000.00) allocated budget for the construction of the City Hall Annex.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod of Muntinlupa that the City Mayor, Hon. Ignacio R. Bunye be authorized to enter into a supplemental agreement with D. L. Cervantes Construction for the change order or additional work in the on-going project "City Hall Annex Building."

APPROVED by the Sangguniang Panglungsod of Muntinlupa this 16th day of June 1997, on its 86th Regular Session.





