WHEREAS, the Project (PATHWAY CONCRETING and DRAINAGE SYSTEM COVER) located at Purok 1, 2 and 3, Sucat, Muntinlupa City, chargeable against 1996 Executive Budget, was one of the priorities of the City Government of Muntinlupa;

WHEREAS, there was a need for an immediate prosecution of the Project by reason that the Pathway was heavily damaged, the Drainage System was over flowing and if not repaired immediately it may affect the health of the people nearby:

WHEREAS, due to the urgency of the Project, and in order to prevent loss or damage to the property and life of the people and by reason that the City Government cannot prosecute the project by administration, said project was awarded through negotiated contract to Morning Sun Builders at the Approved Agency Estimate (AAE) in the amount of One Hundred Seventy Thousand Ninety-Eight Pesos and 98/100 (P170,098.98);

WHEREAS, the contract amount of One Hundred Seventy Thousand Ninety-Eight Pesos and 98/100 (P170,098.98) was charged to Executive Budget 1996 under Request for Obligation and Allotment (ROA) No. 10196030258;

WHEREAS, the Project is already finished and satisfactorily completed as certified by the acceptance and inspection report of the Department of Interior and Local Government:
