WHEREAS, the project (ROAD WIDENING OF MONTILLANO STREET), is one of the priorities of the City Government of Muntinlupa;

WHEREAS, in the Public Bidding held on 26 June 1996, the Contractor, VIC VERA BUILDERS, INC., offered the lowest bid, and as per Resolution of the Pre-Qualification, Bid and Award Committee, it is recommended that the construction of the Project be awarded to the contractor in the amount of Five Million, Eight Hundred Eighty-Two Thousand, Eight Hundred Twenty-Nine Pesos and 70/100 (P5,882,829.70);

WHEREAS, on October 30, 1996, Mayor Ignacio R. Bunye, in a letter to Vice-Mayor Jaime R. Fresnedi requested the City Council to grant him authority to enter into a contract with VIC VERA BUILDERS, INC., for the construction of the project. The letter states :




