WHEREAS, the Project, Construction of Two Storey Multi-Purpose Building, Phase I. located at Muntinlupa Central Elementary School, is one of the priorities of the City Government of Muntinlupa.

WHEREAS, per Resolution of the Pre-qualification. Bid and Award Committee dated December 26, 1994, the project was awarded to A.P. Melendrez Construction, the winning bidder.

WHEREAS. Phase I of the construction had a project cost of Nine Hundred Ninety-Six Thousand, Three Hundred Eighty-Nine Pesos (P996.389.00):

WHEREAS, the scope of works in Phase I was completed. These were: (1) Earthworks. (2) Concrete works like footing, footing tie beam/wall, footing slab on fill, columns and second floor beams:

WHEREAS, this project has Phase II. consisting of the following scope of works roof beams, suspended slab, stair lintel, canopy, concrete gutter, plant box, pathway and ramp, masonry works, carpentry works like ceiling, roofing, partition and cabinets, form works, tinsmitry, electrical works, plumbing works, painting works and finishing works, tile works, doors and windows and balcony railing:

WHEREAS, after completion of phase I the Principal of the School requested the City Engineering's Office and the Contractor to continue the construction of Phase II and for additional works indicated in the letter dated December 7, 1995 to Mayor Ignacio R. Bunye sent by Mrs

Belen Garcia, Principal. These additional works were:

- 4. Change of partition wall from CHB to plywood at the first and second floors to make partition removable:
- 5. Installation of removable partition and filing cabinet of each room and office of the principal
- 6. Installation of concrete working table with cabinet and tiles in the cooking area:

WHEREAS, at the time of construction of Phase II, there was no available Fund for the Project. After completion of Phase I the contractor, at its own risk continue to work portions of Phase II, as follows:

- 1. Roof beams (phase II)
- Suspended slab
- 3. Stair/lintel
- 4. Canopy, concrete gutter, plant box, pathway and ramp
- 5. Masonry works
- 6. Carpentry works
- 7. Ceiling works
- 8. Roofing, partition, cabinet
- 9. Form works
- 10. Tinsmitry works
- 11 Electric works (roughing-in)
- 12. Doors
- 13. Plumbing works (roughing-in)
- Balcony railings
- 15. Painting (first coating)

WHEREAS, Phase I was satisfactorily completed and without negative slippage per occular inspection dated January 6, 1996 of Zosimo Tabajonda, Jr., members, Monitoring Committee and Certificate of Acceptance of Eng'r. Roberto Bunyi and Eng'r. Hector Baltazar

WHEREAS, the Principal of Muntinlupa Elementary School in a letter dated April 25, 1997 requested Mayor Ignacio R. Bunye to immediately complete the project because the same is being used as additional classrooms:

WHEREAS, per bill of materials, the project cost of Phase II as approved by the City Government of Muntinlupa is Two Million One Hundred Forty-Six Thousand, Ninety-Four Pesos and 85/100 (P2.146.094.85):
