A RESOLUTION GIVING THE MAYOR, HON. IGNACIO R. BUNYE, AUTHORITY TO ENTER INTO AN AGREEMENT WITH ARTURO MANALANG REGARDING THE RIGHT-OF-WAY IN ALMANVILLE SUBDIVISION, PUTATAN, AMOUNTING TO ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00), WHICH RIGHT-OF-WAY SHALL BE USED FOR THE CONSTRUCTION OF A DRAINAGE SYSTEM.

WHEREAS, flood problem in the Umali Compound and neighboring areas has long been unsolved because the drainage system cannot be constructed as there is no right of way from the area to Almanville Subdivision towards National Road.

WHEREAS, after series of negotiation of the City Engineering Office and the Office of the City Mayor, Arturo Manalang, the owner of the lot in Almanville Subdivision, agrees to grant the City Government a right of way where the drainage system can be constructed, provided the City Government shall pay him about **One Million Five Hundred Thousand Pesos (P1,500,000.00)**;

WHEREAS, the drainage line to be constructed has about two hundred (200) meters - more or less inside the Almanville Subdivision owned by Arturo Manalang;

WHEREAS, pursuant to the letter, dated July 21 1997, to the Mayor Ignacio R. Bunye the drainage system will benefit more than 1,300 families from the Gonzales Compound, Summitville, Putatan Urban Poor Association, Carey Homes, Umali Compound, Summit Circle, Almanville and Esporlas Compound.

WHEREAS, the same letter dated July 21, 1997, of Engineer Danilo Marcelo - Assistant City Engineer, noted by Mr. Florencio Ciriaco - City Administrator, Atty. Raul Cortes - City Attorney, Eng'r. Roberto Bunyi - City Engineer and approved by Mayor Ignacio R. Bunye, endorsed the proposed Memorandum of Agreement for urgent approval of the City Council.

WHEREAS, on the correctness of the reasonable compensation of the use of the right of way, the City Council relies on the recommendation of the City Engineering Office and Office of the City Mayor;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panglungsod to grant the Mayor, Hon. Ignacio R. Bunye, authority to enter into an agreement with Arturo Manalang regarding the right-of-way in Almanville Subdivision, Putatan, amounting to One million Five Hundred Thousand Pesos (P1,500,000.00), which right-of-way shall be used for the construction of a drainage system.

APPROVED by the Sangguniang Panglungsod of Muntinlupa this 11th day of September 1997, on its Special Session.




