WHEREAS, there is a budget of Six Hundred Fifty Thousand Pesos (P650,000.00) from the General Fund, Capital Outlay - 1997 Infrastructure Development Project allocated for the PROJECT:

WHEREAS, in the public bidding held on 2 July 1997, three (3) bidders submitted their bid:

WHEREAS, the Approved Agency Estimate (AAE) for the PROJECT is Five Hundred Eighty Four Thousand Three Hundred Two Pesos and 78/100 (P584,302.78) and the Allowable Government Estimate (AGE) is Six Hundred Sixteen Thousand Three Hundred Nineteen Pesos and 22/100 (P616,319.22):

WHEREAS, the bid price offered by the lowest bidder, amounting to Six Hundred Forty Five Thousand Four Hundred Forty One Pesos (P645,441.00) is 10.46% and 4.73% above the Approved Agency Estimate (AAE) and Allowable Government Estimate (AGE), respectively:
