WHEREAS, the PROJECT (REPAIR OF WATER SYSTEM) located at Pedro E. Diaz High School, Alabang, Muntinlupa City, is one of the priorities of the City of Muntinlupa.

WHEREAS, there is a budget of One Hundred Thousand Pesos (P100,000.00) from the 1996 Local School Board Fund allocated for the PROJECT;

WHEREAS, in the public bidding held on 2 July 1997, three (3) bidders submitted their bid:

WHEREAS, the Approved Agency Estimate (AAE) for the PROJECT is Ninety Seven Thousand Five Hundred Fifty Eight Pesos and 70/100 (P97,558.70) and the Allowable Government Estimate (AGE) is One Hundred Three Thousand Eight Hundred Sixty Five Pesos and 56/100 (P103,865.56);

WHEREAS, the bid price offered by the lowest bidder (J. B. A. Espejo Construction) is Ninety Nine Thousand Seven Hundred Seventy Six Pesos and 13/100 (P99,776.13) which is 2.27% above and 3.94% below the Approved Agency Estimate (AAE) and Allowable Government Estimate (AGE), respectively;
