WHEREAS, there is a budget of Three Hundred Eighty Thousand Pesos (P380,000.00) from the General Fund, Capital Outlay-Infrastructure Development Budget allocated for the PROJECT;

WHEREAS, in the public bidding held on 7 July 1997, three (3) bidders submitted their bids:

WHEREAS, the Approved Agency Estimate (AAE) for the PROJECT is Three hundred Seventy Nine Thousand Six Hundred Ninety Five Pesos and 37/100 (P379,695.37) and the Allowable Government Estimate (AGE) is Three Hundred Ninety Nine Thousand One Hundred Twenty Five Pesos and 18/100 (P399,125.18):

WHEREAS, the bid price offered by the lowest bidder is Four Hundred Seventeen Thousand Six Hundred Sixty Five Pesos (P417,665.00) which is 10.00% and 3.85 % above the Approved agency Estimate (AAE) and Allowable Government Estimate (AGE), respectively:
