RESOLUTION AUTHORIZING THE MAYOR, HON. IGNACIO R. BUNYE TO ENTER INTO A NEGOTIATED CONTRACT WITH VIC VERA BUILDERS, INC. IN THE CONSTRUCTION OF THE ROAD IN BLOCKS 10-11, SOLDIERS HILLS, PUTATAN, MUNTINLUPA CITY.

WHEREAS, last June 6, 1996, the City Council passed and approved Ordinance No. 96-76. This Ordinance allowed the City Government to construct 118 linear meters of the road in Blks. 9, 10, 11 and 12, Soldiers Hills;

WHEREAS, pursuant to this Ordinance and based on the public bidding conducted, the City Council passed and approved Resolution No. 97-34 on May 3, 1997 allowing the City Mayor to enter into a Construction Agreement with the Vic Vera Builders, Inc. to construct the said road.

WHEREAS, on July 10, 1997, the Vic Vera Builders, Inc. started the construction of the said street. On August 10, 1997, 94.46 % of the construction was already completed. After August 10, 1997, the contractor has been making the side grading, compaction and laying the ready mixed concrete;

WHEREAS, as the concreting is up to 118 meters only, there is a need to continue constructing the street in Blks. 10-11 because vehicles, including tricycles, can no longer pass as the said street is already destroyed;

WHEREAS, this project (construction of the 257 linear meters road) is a continuation of, contiguous and adjacent to the on-going construction of the 118 linear meters road of Blk. 9, 10, 11, and 12;

WHEREAS, the unit price of this project is the same or even lower than the on going project because there is no mobilization fund added.



WHEREAS, there is a budget of **Two Million Five Hundred Thousand Pesos (P2,500,000.00)** allocated for the project.


